Collection Overview

Scope and Content Note

The newly-opened materials from the Theodore C. Sorensen Personal Papers collection consists of material generated by Sorensen during the course of his professional career. While this

material contains documentation of his early days, as well as time spent as a member of John F. Kennedy's Senate office and presidential administration, the bulk of the material centers on his time working in the private sector. Following his time in Washington, D.C., Sorensen wrote books and articles, and made speaking appearances at home and abroad. Throughout his life he remained involved in politics at both the national and local level. He remained interested in world politics, as well — often having an opportunity to meet with various world leaders. These materials, comprised of letters, speeches, memoranda, drafts, articles, notes, publications, news clippings, and e-mail, among others, reflect Sorensen's activities in these areas. Topics covered in this collection include national and local politics, elections, campaigns, and current events of the day. A major topic throughout is John F. Kennedy and his legacy.

These materials were gathered and donated to the John F. Kennedy Presidential Library over time and therefore, an order has been imposed to facilitate a more streamlined research experience. The materials have been organized into six new series: Correspondence Files, 1964-2010; Writings, Interviews, and Appearances Files, 1960-2010; Political Files, 1965-2010; Files Related to John F. Kennedy, 1956-2010; Calendars, 1961-2010; and Personal Files, 1938-2010. Please note that there is considerable duplication within these series, as well as with previously opened material in this collection. Researchers are encouraged to closely study the finding aids available to ensure they have located all relevant material on their topic.

This series contains both professional and personal correspondence sent and received by Ted Sorensen. The correspondence covers a variety of topics including materials related to speaking arrangements; speeches or appearances made; questions from the public about his time in the Kennedy administration for books, dissertations, and school projects; autograph requests; events; travel; fundraising; and national and local politics. The bulk of the correspondence was created and maintained during Sorensen's time at Paul, Weiss, Rifkind, Wharton and Garrison. It provides a comprehensive look at

Sorensen's activities from the late 1960s until his death in 2010. A great deal of Sorensen's correspondence was handled by his secretary, Marge Hornblower. Researchers will find many of Ms. Hornblower's notes within these files.

This series is a broad collection of materials related to Ted Sorensen's writings, speeches, appearances, and interviews over the years. Materials related to Sorensen's writings include correspondence, drafts, notes, and research materials regarding books, speeches, articles, op-eds, and congressional testimony. Of note are the drafts and research materials related to Sorensen's memoir, *Counselor: A Life at the Edge of History*. This series also includes material related to Sorensen's speaking engagements across the United States and abroad. These materials often include administrative information like invitations, scheduling, and travel arrangements. (Researchers are encouraged to check the Correspondence Files series around dates of interest.) For a period of time, subject files were maintained to keep track of materials on various topics for Sorensen's reference. However, the researcher will note that there is a great deal of duplication within this series, as new files were often created for a similar topic, article, speech, or appearance.
